- Returns:** Returns will not be accepted without prior written consent. Generally edible items may not be returned due to tampering laws. If an item has a recall or manufacturer defect, the Purchaser will settle the issue directly with the product manufacturer. If a return is authorized, all merchandise must be in original packaging, unopened and in the original condition as shipped. Once product is received and inspected, credit will be processed within one week. No credit is given for shipping costs.
- Limitation of Liability:** In no event will we be liable for indirect, incidental, consequential, punitive or exemplary damages, nor shall the total liability of Seller exceed the amount paid for the Products.
